TERMS AND CONDITIONS FOR THE SALE AND PURCHASE OF DEBENTURE TICKETS ON THE OFFICIAL MARKET

SECTION 1: INTRODUCTION

- From time to time, The All England Lawn Tennis Club (Championships) Limited (“AELTC”) may purchase debenture tickets from registered debenture holders (“**debenture holder**” / “**you**” / “**your**”). The AELTC may resell these debenture tickets, including to other debenture holders.
- These terms and conditions (“**Conditions**”) are divided into the following sections:
 - **Section 1 (Introduction)** - this section introduces the Official Market process and the terms applicable to the Official Market and use of debenture tickets.
 - **Section 2 (Selling your Debenture Tickets)** - these terms apply to any sale by a debenture holder of debenture tickets to the AELTC.
 - **Section 3 (Purchasing Debenture Tickets)** - these terms apply to any sale of debenture tickets by the AELTC to any debenture holder.
 - **Section 4 (General)** - these terms apply in respect of both the sales referred to in Sections 2 and 3.
- By offering to sell your debenture tickets to the AELTC (as described in Section 2 below) and/or offering to purchase debenture tickets from the AELTC (as described in Section 3 below), you agree to be bound by these Conditions.
- In addition to any capitalised terms otherwise defined throughout these Conditions, for the purposes of these Conditions the following capitalised terms shall have the following meanings:

- “**Behind Closed Doors Championships**” means an edition of The Championships which is held in the absence of physical attendance by members of the public (including debenture holders) at the Grounds;
 - “**Conditions of Entry**” means the terms and conditions of entry to the Grounds issued by the AELTC, the current version of which being accessible at www.wimbledon.com/en_GB/atoz/conditions_of_entry.html;
 - “**Grounds**” means the tennis courts, grounds and buildings on Church Road in Wimbledon, London SW19 5AE known as The All England Lawn Tennis Club;
 - “**Official Market**” means the process established by the AELTC through which registered debenture holders may sell debenture tickets to, and purchase debenture tickets from, the AELTC at prices published by the AELTC;
 - “**The Championships**” or “**Championships**” means ‘The Championships, Wimbledon’ international tennis tournament hosted and staged at the Grounds in June and/or July each year;
 - “**Ticket Terms and Conditions**” means the terms and conditions applicable to the purchase and use of tickets for The Championships issued by the AELTC, the current version of which being accessible at www.wimbledon.com/en_GB/tickets/ticket_terms_and_conditions.html; and
 - “**Void Day**” means any day of The Championships which is abandoned or day where members of the public are prevented from physically attending for reasons described in Section 2(7) and Section 3(7), as applicable.
5. Any personal information provided to the AELTC in connection with these Conditions will be processed in accordance with the AELTC’s Privacy Policy, the current version of which can be found at www.wimbledon.com/en_GB/aboutwimbledon/privacy_policy.html.
 6. Any use of Debenture Tickets, including those purchased through the Official Market in accordance with Section 3 below, remain at all times subject to the Ticket Terms and Conditions and the Conditions of Entry.
 7. Each debenture holder’s attention is particularly drawn to the following sections of the Ticket Terms and Conditions:
 - a. Part C (Terms of Use) which sets out terms and conditions applicable to the use of all tickets for The Championships, including Clause 9 of Part C which sets out specific rules and restrictions in relation to the transfer and use of debenture tickets; and
 - b. Part D (Refund Policy) which establishes circumstances in which certain ticket purchasers (including registered debenture holders) may be entitled to a ticket refund.
 8. Holders of debenture tickets who have accessibility seating needs should contact the AELTC Debenture Office as soon as practicable to ensure that, as far as reasonably possible, the AELTC can accommodate their accessibility requirements.

SECTION 2: SELLING YOUR DEBENTURE TICKETS

1. When you confirm your request via the Official Market webpage by accessing and logging in to the relevant section of the AELTC’s official website, www.wimbledon.com, or by submitting a request by email or by post in the form specified by the AELTC (in each case, an “**Official Market Selling Request**”), you are making an offer to the AELTC to sell the number of debenture tickets you have specified for the published purchase price (such price as viewed on the Official Market webpage) (“**AELTC Purchase Price**”). The AELTC may accept or reject that offer and will communicate its decision to you in writing by email or by post.
2. If the AELTC accepts your offer to sell your debenture ticket(s), you commit to selling the specified debenture ticket(s) to the AELTC for the AELTC Purchase Price.
3. If the AELTC accepts your offer to sell your specified debenture ticket(s) and any of the relevant debenture tickets have already been issued to you, those debenture tickets will be void and you will not be permitted to use them or to sell them to anyone else.
4. If you sell back your debenture tickets to the AELTC, subject to the provisions of Sections 2(6) and 2(7) below in respect of cancellation, abandonment or Behind Closed Doors Championships, the AELTC will pay you the AELTC Purchase Price using the bank account details you have provided. It is your responsibility to make sure the bank account details you provide are correct prior to offering to sell back your debenture ticket(s). The AELTC will endeavour to communicate its decision and, if your offer to sell the specified debenture ticket(s) is accepted, pay you the AELTC Purchase Price within ten (10) working days of you submitting your request to sell.
5. Subject to the provisions of Sections 2(6) and 2(7) below, by selling any of your debenture tickets to the AELTC through the Official Market, you waive any entitlement you may have to a ticket refund as set out in Part D (Refund Policy) of the Ticket Terms and Conditions in respect of such debenture tickets.

Cancellation or staging of Behind Closed Doors Championships

6. If The Championships in respect of which you are selling any debenture ticket(s) to the AELTC are, due to any Government restrictions or applicable laws or regulations adversely impacting attendance at sporting events, subsequently (i) cancelled or (ii) staged as Behind Closed Doors Championships prior to the start of the relevant Championships, then the following terms will apply:

- a. if you have already been paid the AELTC Purchase Price for the debenture ticket(s) you sold to the AELTC at the time that the AELTC issues a public notification that The Championships have been cancelled or will be staged as Behind Closed Doors Championships, then irrespective of whether the AELTC has been able to resell your debenture ticket(s), any previous agreement from the AELTC to purchase such debenture ticket(s) will be cancelled and you will be required to refund the AELTC Purchase Price amount you have been paid to the AELTC. The AELTC will contact you with details of how to make this payment at the relevant time; or
- b. if you have not yet been paid the AELTC Purchase Price for the debenture ticket(s) you have sold to the AELTC at the time that the AELTC issues a public notification that The Championships have been cancelled or will be staged as Behind Closed Doors Championships, any previous agreement from the AELTC to purchase your debenture ticket(s) will be cancelled and the AELTC will not be obliged to pay you for the debenture ticket(s) you have sold back.

Abandonment or staging of Behind Closed Doors Championships

7. If The Championships in respect of which you are selling any debenture ticket(s) to the AELTC are, following their commencement and due to any Government restrictions or applicable laws or regulations adversely impacting attendance at sporting events, subsequently (i) abandoned or (ii) become Behind Closed Doors Championships prior to being completed (whether in full or on individual days), then in respect of the debenture ticket(s) that you have sold to the AELTC that relate to Void Days, any previous agreement from the AELTC to purchase such debenture ticket(s) for the Void Days will be cancelled and:
 - a. if you have already been paid the AELTC Purchase Price for your debenture ticket(s), you will be required to refund such amount of the AELTC Purchase Price as relates to the Void Days. The AELTC will contact you with details of how to make this payment at the relevant time; or
 - b. if you have not yet been paid the AELTC Purchase Price for your debenture ticket(s), the AELTC will not be obliged to pay you for any debenture ticket(s) you have sold back relating to the Void Days.

SECTION 3: PURCHASING DEBENTURE TICKETS

1. When you confirm your request via the Official Market webpage by accessing and logging in to the relevant section of the AELTC's official website, www.wimbledon.com, or by submitting a request by email in the form specific by the AELTC (in each case, an "**Official Market Purchase Request**"), you are making an offer to the AELTC to purchase the number of debenture tickets you have specified for the published purchase price (such price as may be viewed on the Official Market website) ("**AELTC Sale Price**"). The AELTC may accept or reject your offer and will communicate its decision to you in writing by email or by post.
2. If the AELTC accepts all or part of your offer to purchase additional debenture tickets, subject to the terms in Sections 3(6) and 3(7) below in respect of cancellation, abandonment or Behind Closed Doors Championships, you commit to purchasing the specified debenture ticket(s) from the AELTC for the AELTC Sale Price.
3. The AELTC will send you a VAT invoice, which will need to be paid immediately and in any case before you receive your debenture ticket(s).
4. You acknowledge and agree that all debenture ticket purchases are final and that (save as may be provided in Sections 3(6) and 3(7) below) no cancellations will be permitted, including under the Consumer Contracts (Information, Cancellation and Additional Charges) Regulations 2013, and/or refunds or exchanges given following the AELTC's receipt of payment for the debenture ticket(s). However, you may be able to sell debenture ticket(s) to the AELTC in accordance with Section 2 above or sell or transfer them to another person in accordance with the Ticket Terms and Conditions.
5. The additional debenture ticket(s) purchased may be located anywhere within the court. The AELTC cannot guarantee that the seat(s) of your additional purchased debenture ticket(s) will be next to the seat(s) of your original debenture ticket(s).

Cancellation or staging of Behind Closed Doors Championships

6. If The Championships in respect of which you are purchasing debenture ticket(s) from the AELTC are, due to any Government restrictions or applicable laws or regulations adversely impacting attendance at sporting events, subsequently (i) cancelled or (ii) staged as Behind Closed Doors Championships prior to the start of the relevant Championships, then the following terms will apply:
 - a. if you have already paid the AELTC Sale Price for the debenture ticket(s) you bought from the AELTC at the time that the AELTC issues a public notification that The Championships have been cancelled or will be staged as Behind Closed Doors Championships, then irrespective of whether you have been able to resell your debenture ticket(s), any previous agreement from you to purchase such debenture ticket(s) will be cancelled and the AELTC will refund the AELTC Sale Price you paid to the AELTC. It is your responsibility to ensure you provide the AELTC with the correct bank account details to make this payment at the relevant time; or
 - b. if you have not yet paid the AELTC Sale Price for the debenture ticket(s) you are purchasing from the AELTC at the time that the AELTC issues a public notification that The Championships have been cancelled or will be staged as Behind Closed Doors Championships, any previous agreement from you to purchase such debenture ticket(s) will be cancelled and you will not be obliged to pay the AELTC for the debenture ticket(s) you were purchasing.

Abandonment or staging of Behind Closed Doors Championships

7. If The Championships in respect of which you are purchasing debenture ticket(s) from the AELTC are, following their commencement and due to any Government restrictions or applicable laws or regulations adversely impacting attendance at sporting events, subsequently (i) abandoned or (ii) become Behind Closed Doors Championships prior to being completed (whether in full or on individual days), then in respect of the debenture tickets that you have bought from the AELTC that relate to Void Days, any previous agreement from you to purchase such debenture ticket(s) for the Void Days will be cancelled and:
 - a. if you have already paid the AELTC Sale Price for your debenture ticket(s), the AELTC will refund such amount of the AELTC Sale Price as relates to the Void Days. It is your responsibility to ensure you provide the AELTC with the correct bank account details to make this payment at the relevant time; or
 - b. if you have not yet paid the AELTC Sale Price for your debenture ticket(s), you will not be obliged to pay the AELTC for any debenture ticket(s) you have bought relating to Void Days.

SECTION 4: GENERAL

1. The AELTC may update these Conditions from time to time. Any changes will not affect any debenture tickets purchased or sold under a previous version of these Conditions.
2. Each of the terms of these Conditions operates separately. If a court finds any part of these Conditions to be unlawful or unenforceable, the remaining provisions will continue in force.
3. These Conditions are governed by the laws of England and, if there is any dispute arising from or in connection with these Conditions, you may only bring a claim in the English courts, however, if you reside elsewhere in the United Kingdom or in the European Union, you still have the benefit of any applicable rights under the laws of, and the right to bring an action before the courts of, your country of habitual residence.
